THIS PROGRAM PROVIDED A TOTAL OF 10,877 SERVICE VISITS. WE FILED TAX RETURNS FOR 85 FAMILIES, PROVIDING EARNED INCOME TAX CREDIT (EITC) TOTALING \$42,537 AND CHILD TAX CREDIT (CTC) OF \$38,253. THE TWO CLINICS RELY ON AN INNOVATIVE VOLUNTEER-BASED MODEL OF SERVICE THAT USES VOLUNTEER MEDICAL PROFESSIONALS, INCLUDING PHYSICIANS, NURSES, DENTISTS, NURSE PRACTITIONERS, INTERPRETERS, AND OTHER CLINICAL AND ADMINISTRATIVE VOLUNTEERS TO OPERATE THE CLINIC.
