THIS PROGRAM PROVIDED A TOTAL OF 9,707 SERVICE VISITS. WE FILED TAX RETURNS FOR 229 FAMILIES, PROVIDING EARNED INCOME TAX CREDIT (EITC) TOTALLY \$84,342 AND CHILD TAX CREDIT (CTC) OF \$71,390. FREE MEDICAL AND DENTAL CLINICS IN SAN MATEO AND REDWOOD CITY PROVIDE MORE THAN 10,100 PATIENT VISITS DURING THE YEAR TO UNINSURED LOW-INCOME INDIVIDUALS. THE TWO CLINICS RELY ON AN INNOVATIVE VOLUNTEER-BASED MODEL OF SERVICE THAT USES VOLUNTEER MEDICAL PROFESSIONALS, INCLUDING PHYSICIANS, NURSES, DENTISTS, NURSE PRACTITIONERS, INTERPRETERS, AND OTHER CLINICAL AND ADMINISTRATIVE VOLUNTEERS TO OPERATE THE CLINIC. SAFE HARBOR IS A 90-BED HOMELESS SHELTER PROVIDING EMERGENCY/TRANSITIONAL HOUSING AND SUPPORTIVE SERVICES FOR HOMELESS MEN AND WOMEN. SUPPORTIVE SERVICES INCLUDE: CASE MANAGEMENT, ACCESS TO COMMUNITY SERVICES, EMPLOYMENT AND FINANCIAL COUNSELING, MENTAL HEALTH SERVICES, SUPPORT GROUPS, HEALTH SERVICES, TRANSPORTATION, HYGIENE SUPPLIES, FOOD, BENEFITS ASSISTANCE, HOUSING ASSISTANCE REFERRALS, INFORMATION, REFERRAL AND ACCESS TO OTHER RESOURCES AS NEEDED.
